

KSM-66[®]

Trademark License Agreement

This agreement is between Ixoreal BioMed and the firm/firms (henceforth in this document referred to as "Customer") whose authorized signatory/signatories is/are listed near the end of this document.

KSM-66 supplied by Ixoreal Biomed Inc. is an all-natural proprietary ingredient. Due to the unique properties of this ingredient, the Customer agrees to the following criteria, terms and conditions which Ixoreal Biomed Inc. deems necessary to assure the protection of its intellectual property rights, identity and integrity of KSM-66 in the marketplace.

With respect to any product or formulation containing KSM-66, the Customer agrees to the following:

1. If the Customer is purchasing KSM-66, it agrees to purchase KSM-66 directly from Ixoreal Biomed Inc. or through their accredited exclusive agent in its country.
2. If the Customer is the seller, distributor or marketer of a product containing KSM-66, it agrees to list the name KSM-66 on all product(s) ingredient panels and submit the label to Ixoreal Biomed Inc. for final approval, which approval shall not be unreasonably withheld.
3. If the Customer is the seller, distributor or marketer of a product containing KSM-66, it agrees to not display the name of KSM-66, identify KSM-66 or market KSM-66 with any marketing material, logo or artwork, not supplied or approved by Ixoreal Biomed Inc. The exception to this is when the Customer uses the KSM-66 name and logo as part of a label or ingredients panel already approved by Ixoreal Biomed Inc, pursuant to No.2 above

This agreement applies to all products containing KSM-66 sold to the Customer or its purchasing agent(s), whether manufactured, sold, distributed or marketed by the Customer. Other than for use in manufacturing the Customer's own product, the Customer shall not resell or supply KSM-66 in any form, either directly or indirectly, to any third party. Ixoreal Biomed Inc. will supply only to the Customer or its manufacturer. If the Customer is not the manufacturer, the Customer shall inform Ixoreal Biomed Inc. of the name and address of the Customer's manufacturer. If the Customer is a contract manufacturer, and supplies, but does not own or control, the finished product, the contract manufacturer shall (a) inform its customer about the terms and conditions of this agreement and make its best effort to enforce this agreement, and (b) have its customer execute a license agreement with Ixoreal Biomed Inc.

As an addendum to this agreement, the Customer shall provide Ixoreal Biomed Inc. with a current list of products containing KSM-66 Addendum to be updated annually by the Customer listing additions/deletions.

Use of KSM-66 requires that the provisions of this agreement be understood and accepted by all who use and market it. Ixoreal Biomed Inc. may refuse to supply or sell KSM-66 to any person or entity that fails to honor this agreement. However, Customer will be given reasonable time to sell through inventory after receipt of written notification detailing the reasons for terminating this agreement. Ixoreal Biomed Inc. may also pursue any and all legal rights, remedies and recourse in the event of a breach of this Agreement.




